Join us **IN PERSON** this month as Marissa Scott, MSOH, CIH, GSP, an Industrial Hygiene Consultant with Safex discusses “Heat Stress” and how to keep your workers safe in rising heat conditions.

Marissa Scott, MSOH, CIH, GSP, is an industrial hygienist who performs industrial hygiene evaluations, such as indoor air quality assessments, noise monitoring and inhalation exposure assessments for various contaminants. In addition, she conducts quantitative and qualitative fit testing and is an instructor for Safex’s Fundamentals of Industrial Hygiene class.

Prior to joining Safex in March 2020, Marissa was a HSE Processional/Industrial Hygienist with Marathon Petroleum Corporation, in Findlay, Ohio, where she conducted respirator fit testing, noise monitoring and industrial hygiene sampling. Marissa also supported other company components’ industrial hygiene programs throughout the United States. Prior to working at Marathon, Marissa spent three and a half years as an HSE Specialist at Vehtek Systems, Inc., a Tier 1 automotive supplier, and a division of Magna International. There, Marissa was responsible for the oversight of the environmental programs, including the site’s ISO:14001 certificate, as well as the ergonomic programs.

Marissa received her Bachelor of Science in Environmental Science from the University of Toledo in 2012. In 2019, Marissa received her Master of Science in Occupational Health in Industrial Hygiene and her Safety Practitioner® (GSP) designation from the University of Toledo. She became a Certified Industrial Hygienist (CIH) in 2020.
